# CARE AND SOCIAL SERVICES INSPECTORATE WALES - PERFORMANCE EVALUATION REPORT 2014 / 2015 - SOCIAL SERVICES

# **Purpose of report**

To present to Members the Care and Social Service Inspectorate Wales (CSSIW)
 Performance Evaluation Report 2014-15 for the City of Cardiff Council Social
 Care Services; this is attached at Appendix 1. The report also provides the
 opportunity for the Director of Social Services to respond to the CSSIW report.

## **Background**

2. The CSSIW report provides their judgements on both Adults Services and Children's Services and details their findings on the key strengths as well as areas for development and improvement. The report is structured in line with the themes of social services outlined in guidance on the Director of Social Services Annual Report, as set out below¹:

#### • PERFORMANCE

- o Shaping Services
- Getting Help
- o The Services Provided
- o Effect on People's lives.

#### CAPACITY

- Delivering Social Services
- o Providing Direction.

- The Performance Evaluation report for 2014/15 has been amended as compared to previous reports and includes a summary of the findings at section 1 pages 1-2, , followed by a table showing the assessed responses to last year's areas for improvement, section 2 at Page 2
- 4. The report takes into account the Director of Social Services Annual Report 2014-15, as well as the views of other auditors, and draws on inspection work undertaken during the year covering:
  - Site visits to Community Mental Health Teams;
  - The Children's Managed Team and Children in Need Team;
  - Meeting with Senior Managers throughout the year;
  - The inspection of regulated services, run by the Council and by independent operators;
  - Observation of Scrutiny Committees;
  - A national thematic review of the deprivation of liberty safeguarding arrangements;
  - Review of the in house fostering service and children's home; and
  - The Wales Audit Office review of Independence of Older people.

#### Issues

- 5. The report provides a summary of the overall review and evaluation of performance for 2014- 2015. The main messages in the summary, at pages 1 & 2, are:
  - The Director's report presents a clear picture of the challenges and areas of progress made, as well as clearer aims for improvement;
  - Performance indicators show some key areas requiring improvement although the Council is moving in the right direction;
  - Improvements are required in reducing the number of people waiting for Hospital discharge, and Children's intake and assessment needs continued improvement;
  - Planned appointments of assistant directors should enable the department to:

- Take up the strategic challenge it faces;
- Promote integrated services with Health and the Vale of Glamorgan;
- Manage new models of care;
- Promote service users well being in ever increasing financial restraint.
- There is strong corporate support for the delivery of social services;
- Elected members are briefed and understand the implications of the Social Services and Wellbeing Act;
- Good corporate understanding of the challenges facing the department and the difficulties it faces in its efforts to provide services to the most vulnerable.

## Areas to follow up next year

A number of specific areas for improvement have been identified which will be monitored and discussed during regular engagement meetings, **section 4 page 3**:

- The Council's approach to improve performance in the number of delayed transfer of care from hospital;
- The commissioning arrangements for residential and domiciliary care;
- Performance within children's services, in particular intake and assessment and children in need;
- Progress on the payment by results initiative in enabling young people to provided with a service in Cardiff, and
- Readiness for the Social Services and Wellbeing Act.

## Areas for Improvement in Adult Services, page 8

- Timeliness of completing reviews of older people's care needs;
- Implementation of a quality element in the commission of residential care;
- Increase in the delivery of domiciliary care; and
- Improved performance in reducing delayed transfer of care.

## Areas for Improvement in Children's Services, page 12

- Continue to increase the uptake of direct payments;
- Continue to increase the number of permanently appointed social workers
- Improve performance in completing PEP's;
- Recruitment of personal advisers; and
- Completion of initial and core assessments.

## Inspection and review plan for 2015 – 16

The CSSIW will be undertaking the following inspections in Cardiff, section 5 page 4:

- National review of domiciliary care
- National review of services for people with learning difficulties
- National review of care planning for looked after children;

Councillor Sue Lent, (Deputy Leader and Cabinet Member for Early Years, Children and Families) and Councillor Susan Elsmore, (Cabinet Member for Health, Housing and Well Being) have been invited to attend to respond to the report, attached as **Appendix 1**, and will be available to answer any questions that Members have, along with Tony Young (Director of Social Services).
