Day Opportunities Strategy Consultation

Our provision of elderly care services is facing challenges, which will result in changes to the way that elderly day services work in the city. This is due to a significant growth in the overall population, an increasing number of older people, a need to improve the ability of the service to meet those with higher levels of need, and the need to help to reduce loneliness.


Building on last year's consultation, the Council has developed a model for day services with a set of proposals that will deliver the outcomes that people will want in order to improve their lives. The model consists of three tiers that differentiate between types of day services based on the needs of the service users. It is proposed that the Day Opportunities Strategy will aim to prevent social isolation by enabling older people to achieve their chosen outcome by:

- Providing information, advice and assistance to encourage independent access to social activities and engagement opportunities
- Providing assistance to those who need it to access community services and activity through targeted intervention and support
- Supporting the most vulnerable through high quality specialist day services





The Council must ensure that spending is focused on the areas that are most important and that make the biggest difference in supporting people. It also means we need to make sure that each pound goes as far as possible through working successfully with partners and community groups. This is so we can meet the needs of people who have the highest care and support needs and the most vulnerable people in our communities.

We propose to create a Day Opportunities Team to support older people to access community facilities. This could involve a support worker accompanying someone to a local activity in the first instance or arranging community transport to a luncheon club and helping them in their first few visits.

The model recommends that those with the highest care and support needs (including dementia) will need to have access to a specialist Day Centre. This will help to support carers by providing respite from caring. There are currently three council run day centres at Minehead Road, Grand Avenue and Fairwater, in addition to the council-funded Oldwell Court Day Centre run by the Alzheimer's Society.

The proposal is for

- Minehead Road and Fairwater to remain as Day Centres for those with high care and support need and lower levels of dementia.
- Grand Avenue/Ely to become a specialist dementia centre. This will allow us to partner with Health to provide a joined-up service.
- Alzheimer's Service at Oldwell Court not to be funded as the current provision does not meet the needs of the individuals with the highest needs and those needs would be best met from one of the centres above.

It is anticipated that current Day Centre users will still be able to access Day Centres as part of the new proposal.

By making these changes we can continue to provide sustainable and high quality Day Centre services.

It was previously agreed that the Council would stop providing the Meals on Wheels service. Although not a statutory service, it is an important service for people to receive a regular hot meal and it provides an essential social contact for many older people. Currently the service does not cover its costs and meals are therefore provided at a subsidy. Therefore if we are to continue to provide this service it will need to be cost effective. Proposals to make the service self-sustaining include expanding the service, exploring different meal options and increasing the cost of a hot meal by £1, from £2.90 to £3.90.

Luncheon clubs have an important role to play in preventing social isolation. We are aware of 30 Luncheon Clubs in the city, two of which receive a subsidy. The two receiving subsidy are based at Moorland Road and Dalton Street. We want to see a sustainable and equitable provision across the city and therefore are proposing the withdrawal of specific funding.


